

# GREENHOUSE AND ENERGY MINIMUM STANDARDS (GEMS)

# **Compliance - Check Testing Results**

July 2021 to June 2022 (final report)



### **Purpose**

To report on the selection and check testing of models of Greenhouse and Energy Minimum Standards (GEMS) products undertaken between 1 July 2021 and 30 June 2022.

#### **Background**

Check testing refers to principles and procedures the GEMS Regulator uses to verify whether GEMS product models meet minimum energy performance standards (MEPS) and the energy efficiency claims of manufacturers and suppliers.

Check tests are conducted on behalf of the GEMS Regulator by National Association of Testing Authorities (NATA) accredited or affiliated laboratories either in Australia or overseas. The check testing results have been published in accordance with section 162 of the GEMS Act 2012.

#### **Products tested**

Between 1 July 2021 and 30 June 2022<sup>1</sup>, the GEMS Regulator undertook stage 1 check testing of 61 models for ten GEMS products<sup>2</sup>.

At the date of reporting:

- 55 models passed the relevant GEMS Determination level requirements, and
- 6 models failed either stage 1 or stage 2 check testing and have subsequently had their registration cancelled and can no longer be offered for sale or supply.
